Submission content:

The proposed AFL stadium at Macquarie Point does not, I believe, have community licence.

The stadium would have 31m high walls. The bulk and height is not suitable as this area is surrounded by the Cenotaph and heritage buildings. The heritage-listed goods shed would be demolished if the stadium goes ahead.

The existing plan for housing, an Aboriginal area, Antarctic base, and serviced outdoor areas for locals and tourists has community licence. The Hobart Precinct Plan includes community-acceptable planning guidelines for the area.

Hobart has become the latest case study in how a city's economic, social and design priorities can be sabotaged when powerful sporting organisations start calling the shots and governments fall into line.

Evidence from numerous studies shows there is no improvement in employment from building stadiums.

A cost/benefit analysis shows that the stadium will lose \$300 million over 20 years of operation i.e. \$15 million of our money each year; money badly need elsewhere.

The universal consensus among thousands of academic economists is that new stadiums have very limited net economic impact (in some cases a negative impact) and are NOT justified as worthwhile public investments.

The Government needs to return to its earlier plans for this area.

There are many issues surrounding the stadium debacle that can be described as 'dodgy', but the Bence & Mulcahy rendering of the visual impact of the structure on Hobart's waterfront heritage is not one of them. To be fair, the Premier is not alone in his inability to interpret architectural drawings and renderings. Throughout my years of architectural drafting I've often had to walk clients through the design process and decode plans. Translating two dimensions into a three- dimensional image requires a degree of spatial intelligence we don't all possess. If that's the case for Mr Rockliff, it's beholden upon him to actually read the explanation that accompanied the rendering which outlined quite clearly how the image was created and the criteria upon which it was based. Instead, he insisted his architects publish his own interpretation of how his "not designed yet" structure would look, taken from a completely different vantage point and eye- level. We designers know the reason he'd not wanted this most commonly viewed aspect of the shoehorned monument to be revealed, and it's interesting to note that his architects resisted any accreditation for that particular overlay. Yes, Premier, paddling around in a kayak in Constitution Dock would obscure your view of the stadium behind several rows of pontoons and buildings but that's NOT the view pedestrians on Franklin Wharf and associated docks and piers will have. I have done my own survey, walking around the area, taking photographs, checking height data, calculating sight lines and referring to maps and satellite imagery. From this research I can say that the Premier's alternative image misses the mark in a number of ways. Any photograph from the south can take the 33mtr. Gasworks chinney to the west of
designed IXL courtyard in the middle of the complex, both of which currently rely on passive solar input for warmth in Winter. Rather than being designed to shock which some have alleged, this drawing has been carefully constructed, taking into account sight lines from

			nearby buildings and the dimensions supplied by the government. If the Bence & Mulcahy rendering of the stadium is shocking, it's because the stadium itself is shocking: a shocking waste of money; a shocking waste of space; a shocking loss of opportunity; a shocking trampling of heritage values, and a careless subjugation of Hobart's maritime character. The Princes Park noise levels were found to be sufficiently loud as to be regarded as highly annoying under World Health Organization standards and would have caused awakening reactions in sleeping night shift workers requiring restorative sleep during the day time. These standards were accepted by the State Government in their Environmental Protection Policy (Noise) - 2009. The Macquarie Point Stadium will be hard against residential areas which require the legally accepted local area acoustic standards. It will be just 100 metres from the Federation Concert Hall, and the University Art School, 150 metres from the Grand Chancellor and 400 metres from music concerts which will radiate in all directions. High noise levels will not be just an occasional problem as the stadium will be required to have regular events to pay for itself. These will inevitably include loud music concerts, some with how frequency drumming beats that carry long distances, one day and night cricket games with the associated loud pa systems (that have been disruptive to Bellerive residents adjacent the Blundstone Arena), as well as the day and night football games. For those who say that similarly located grounds such as the MCG do not cause noise problems, it should be noted that the MCG, is more than 1000 metres from the eastern corner of the Melbourne CBD, and is not close to sensitive buildings.
